2018-19 Booking Conditions for Day Heli Packages

I hereby apply to book one of the Selkirk Tangiers Helicopter Skiing LLP (also referred to as STHS) trips as specified in the following terms and conditions which I understand and agree to:

- 1.1 That I will not be permitted to participate in any STHS trip unless a "Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement" is properly signed and witnessed onsite by a qualified STHS staff member.
- 1.2 That STHS requires all participants to be 15 years of age or older. Participants who are 18 years old or younger must have a parent or guardian to co-sign their waiver as well as ski with them at all times. See 'STHS Minor Policy' for details.
- 1.3 It is understood and agreed that it is my responsibility to arrive at the required time and location to commence any trip. It is also my responsibility to ensure proper entry through Canadian Customs and Immigration if entering from outside Canada.
- 1.4 STHS reserves the right to cancel any ski package at any time. Full refunds will be given in this case.
- 1.5 STHS constructs groups based on guest abilities outlined on this form. If abilities are not homogenous, to the point where it adversely affects the heliski program, STHS reserves the right to move guests into other groups that they may fit better with. STHS also reserves the right to not fly a client for their full package if they aren't fit or able to fulfill the minimum fitness and ability level required for that package. No refund to client or agent will be offered in this case.
- 1.6 STHS constructs groups based on client weights outlined on their individual booking form(s). STHS reserves the right to rearrange groups in order to maintain safe group weights as required by Canadian Aviation regulations.
- 1.7 All medical evacuation costs will be the responsibility of the client.

<u>Refund Policy</u> While it is the goal of STHS for all of our guests to ski the full package booked, some circumstances necessitate cancellation of the heli ski day. If cancellation occurs, you will be provided with a partial or full refund, based on the following scenarios:

3 Run Excursion & 5 Run Adventure Refund Policy

- If Selkirk Tangiers cancels the day before your trip, we will try to rebook you if possible. If we are unable to rebook you, we will issue you a 100% refund.
- If Selkirk Tangiers cancels by 7:30 AM on the day of your trip, we will try to rebook you if possible. If we are unable to rebook you, we will issue you a 100% refund and you can enjoy a complimentary breakfast.
- If Selkirk Tangiers cancels after breakfast & safety training and rebooking is not an option, a \$100 administration fee will be kept by STHS, with the remaining balance refunded to you. The administration fee can be used as a credit towards your next Selkirk Tangiers reservation; it will be non-transferrable and valid for two seasons. This will be provided as a voucher directly from STHS via email. A bagged lunch and a lift ticket to Revelstoke Mountain Resort will also be provided. This lift ticket is valid any day of the current season, but is non-transferrable and cannot be resold. If you booked through a wholesale agent, refunds for the above scenarios will be delivered by the wholesale agent to you.
- If we start skiing but the guaranteed number of runs cannot be reached, STHS will refund you \$178 plus tax (double the extra run rate) for each run not achieved.
- In the worst case scenario of only skiing 1 run and rebooking is not an option, we will charge a flat rate of \$440+tax for all one day packages. The remaining balance will be refunded to your credit card in the days following your cancelled package. You will also receive a \$100 credit voucher that can be used as a credit towards your next Selkirk Tangiers reservation; it will be non-transferrable and valid for two seasons. This voucher will be sent via email. A bagged lunch and a lift ticket to Revelstoke Mountain Resort will also be provided. This lift ticket is valid any day of the current season, but is non-transferrable and cannot be resold. If you booked through a wholesale agent, refunds for the above scenarios will be delivered by the wholesale agent to you.

10 Run Expedition Refund Policy

If one of your ski days is cancelled we will try our best to reschedule you on another day. If you cannot be rescheduled, your package will be changed to a one day 5 Run Adventure program and the price difference will be refunded. If you booked through a wholesale agent, the difference will be refunded by the tour agent to you. In this scenario, the following guidelines will apply to your new package:

- You will complete your safety training on the first day even if it's a cancelled ski day.
- If you ski more than 5 runs, extra runs are charged at a rate of \$89/run.
- Any runs not achieved from the 5 run package will be refunded at the \$178 + tax (double the extra run rate)
- In the rare circumstance we need to cancel both days, a \$100 administration fee will be kept by STHS. The administration fee can be used as a credit towards your next Selkirk Tangiers reservation; it will be non-transferrable and valid for two seasons. This will be provided as a voucher directly from STHS to you via email. The remaining balance will be refunded directly to you. If you booked through a wholesale agent, the remaining balance will be refunded from the tour agent. A delicious buffet breakfast, bagged lunch and a lift ticket to Revelstoke Mountain Resort will also be provided for each cancelled day.

<u>Transceivers</u> Use of an STHS/RMR issued Barryvox Pulse transceiver is mandatory while skiing with us and it is your responsibility to safeguard and return it to us at the conclusion of your stay. Should the transceiver not be returned, a charge of \$400 + tax will be added to your final bill.
