STHS 2020-21: 1 and 2 Day AStar Program Itinerary

The safety of our guests and team members continues to be our highest priority at Selkirk Tangiers Heli Skiing. As a valued guest, we want you to feel safe, comfortable, and confident throughout your experience with us. To elevate our existing high standards of hygiene and cleanliness, we have developed the Selkirk Tangiers Pure Clean program. For updates on STHS & Hillcrest Hotel COVID-19 protocols, please refer to Page 5 of the itinerary and our website.

On the morning of your heli day, please arrive by 7:15am to our Hillcrest Hotel base location. Upon your check in with one of our STHS Guest Services Representatives we will perform a COVID Health Check following the BC Interior Health Guidelines. At this time, we will review our COVID-19 protocols and client expectations with you. Two masks will also be provided to you. One mask is intended for you to wear at all times within the common area of the Hillcrest Hotel, including the STHS retail area, and the second mask, a "Filtered Neck Tube" (with 99.85% PFE) to be worn while in the STHS shuttle van, in the helicopter or when you cannot maintain the 2-meter distance.

As the situation with Covid-19 is still developing, the STHS reservations team will provide you with an update of any changes in our operating practices one week prior to your arrival.

How your heli day will unfold...

- 7:30am You will be required to sign the STHS waiver, *A realese of Liabilitity, Waiver of Claims, Assumptions of Risks and Indemnity Agreement,* in our Retail Guests service area, the lower elevation of the Hillcrest Hotel. A completed rental form for ski / snowboard rental is required.. You can then proceed to get equiped with the complimentary STHS powder skis or Snowboard . Bring one boot so our ski technicians can set up the bindings.
- **7:30-8:15am** Breakfast: Enjoy your breakfast in the Dining Room on the main floor of the hotel. Please check in with the host(ess) before sitting down. You will be eating with your cohort group.
 - 8:15am Avalanche Airbag rentals: (Optional) Guests wishing to rent an avalanche airbag backpack (\$34 + 5% tax / day) may do so in the retail shop. A rental form is required and an instructional briefing will be provided.
 - 8:30am Meet your guide & weigh in: Your guide will meet you in a designated area, such as the retail store for weigh-in, safety pack, and avalanche tranceiver distribution. Be dressed ready to ski with your ski / snowboard boots on. Every skier must be weighed with their gear on to ensure we do not exceed helicopter weight safety limits. Please note that these weight restrictions may force us to split groups.

If renting, choose a set of ski poles from the boot room as you make your way to your designated shuttle van. Your rental skis/ boards will be ready in the racks outside beside the vans.

- **8:45am Safety training:** Your guide will lead you through a backcountry safety briefing before meeting the helicopter for an orientation of the machine. Once the training is complete your group will either load the helicopter directly or you will be transported by van to a staging area for pickup.
- **10:00am** Heli Skiing: Lift for first runs, then enjoy your café catered lunch in the mountains. Continue skiing until your package is complete.
- **3:00 -4:00pm** Après-ski Return to Coast Hillcrest Resort for check-out at the retail shop followed by gourmet snacks and beverages.
- **On your second day, breakfast starts at 7am in the Hillcrest dining room. Be sure to meet your guide all geared up at your designated van at 8:15am unless otherwise directed.



Getting Here




Our main base is within the **Coast Hillcrest Hotel**, located just off the Trans Canada Highway, 7 kilometers east of the main turnoff into Revelstoke.

- If driving **from the east** you will see the large Hillcrest Hotel sign on the left hand side prior to reaching Revelstoke.
- If driving **from the west**, keep driving past the turnoffs to get into Revelstoke and you will then see the sign on your right hand side. Oak Drive is the road leading off the Trans Canada at this point and it will lead you directly to the Hotel.

Please be sure to check <u>www.drivebc.ca</u> before you start your drive to Revelstoke to keep up to date on the latest road conditions.

Sutton Place Hotel Shuttle: If you are staying at the Sutton Place Hotel at the base of Revelstoke Mountain Resort, please contact us 24 hours prior to your trip to book a complimentary shuttle. This shuttle departs from the Sutton Place Hotel at 7:15am and returns from Selkirk Tangiers around 5:00pm.

Taxi Service: There are two main taxi services operating in Revelstoke. Mornings are busy, so pre-book the night before.

Down Day Refund Policies



While it is the goal at STHS for all of our guests ski their full package, some circumstances necessitate cancellation of the heli ski day, referred to as a "Down Day". There are many factors that effect if the day will be cancelled including but not limited to: inclement weather, mechanical reasons regarding the helicopter or avalanche conditions. If cancellation occurs, you will be provided with a partial or full refund, based on the following scenarios:

Partially Cancelled Day

- If we start skiing but the guaranteed number of runs cannot be reached, STHS will refund you \$210 plus tax for each run not achieved.
- In the worst-case scenario of only skiing 1 run and rebooking is not an option, we will charge a flat
 rate of \$525+tax for all one day packages. The remaining balance will be refunded to your credit card
 in the days following your cancelled package. You will also receive a \$100 credit voucher that can be
 used as a credit towards your next Selkirk Tangiers reservation; it will be non-transferrable and valid
 for two seasons. This voucher will be sent via email. A bagged lunch and a lift ticket to Revelstoke
 Mountain Resort will also be provided. This lift ticket is valid any day of the current season, but is
 non-transferrable and cannot be resold. If you booked through a wholesale agent, refunds for the
 above scenarios will be delivered by the wholesale agent to you.

Down Day

- If Selkirk Tangiers cancels the day before your trip, we will try to rebook you if possible. If we are unable to rebook, we will issue you a 100% refund.
- If Selkirk Tangiers cancels by 7:30 AM on the day of your trip, we will try to rebook you if possible. If we are unable to rebook, we will issue you a 100% refund and you can enjoy a complimentary breakfast and bagged lunch.
- If Selkirk Tangiers cancels after breakfast & safety training and rebooking is not an option, a \$100 administration fee will be kept by STHS, with the remaining balance refunded to you. The administration fee can be used as a credit towards your next Selkirk Tangiers reservation; it will be non-transferrable and valid for two seasons. This will be provided as a voucher directly from STHS via email. A bagged lunch and a lift ticket to Revelstoke Mountain Resort will also be provided. This lift ticket is valid any day of the current season, but is non-transferrable and cannot be resold. If you booked through a wholesale agent, refunds for the above scenarios will be delivered by the wholesale agent to you.

Questions about your package?



What safety equipment is required and/ or provided?

- Every skier/snowboarder will be provided with and required to wear a backpack containing an avalanche probe and shovel. Every other skier/snowboarder will carry a radio.
- All guests must use one of our Barryvox avalanche transceivers. You will practice using "transmit" and "search" modes during the safety briefing on the first morning of your heliski package.

Do you rent skis? Snowboards? Or do I need my own?

- Ski and snowboard rentals are included in your package. Guests can use their own equipment if desired but our gear is specific for powder conditions. Please note that STHS does not offer any package discounts if clients use their own ski/snowboard equipment. We do not rent ski or snowboard boots please bring your own or rent these from a third party.
- Our ski technicians require one boot to set up skis. Please place the other boot on the drying pegs in our boot room, and we will match your boots while you're enjoying breakfast. If you register the evening before your ski day we will keep your boots drying overnight so they are ready in the morning.
- Some of our skis are equipped with touring bindings for people who have ski touring boots. However, ski selection will be limited so we recommend bringing traditional alpine ski boots if you have them.

Where do I find my skis or snowboard in the morning?

• Ski technicians will transfer rental skis and boards to the front of the hotel. But be sure to grab a pair of powder poles if needed, located on a rack in the boot room. Once at the hotel front doors, please ensure you have the correct skis, then help your guide load them onto the van.

Can I bring extra layers and gear?

• Guests may carry small personal items in their pack for the day if necessary. Due to weight constraints and space limitations of the helicopter, we do not allow guests to bring additional packs or heavy items.

Can I use my GoPro, cell phone, etc.?

• Please refer to our Electronics Policy on page 6.

Gluten free? Vegetarian? Allergies?

• Our lunches are ordered from a local caterer prior to your trip. Please include any dietary restrictions on your booking form during registration. Please call or e-mail us **at least 48 hours** in advance to make any changes.

Where do I leave my shoes and extra gear?

• Our STHS boot room can be used for securely storing personal items while eating breakfast or out skiing.

Where do I return my rental skis & boards?

• We will take care of the returns while you enjoy the après ski lounge. Simply leave your equipment on the racks outside at the end of your day, which will be returned to the rental shop.

Do I need to sign a waiver?

As is standard in our industry, each guest is required to sign a **Release of Liability Waiver** prior to skiing. This will be provided during your orientation the evening before your first ski day, and must be witnessed by an STHS staff member. If you would like the waiver in a language other than English, please let our staff know and we will do our best to accommodate.

Etiquette and Safety

Covid-19 Policy



The safety of our guests and team members continues to be our highest priority at Selkirk Tangiers Heli Skiing. As a valued guest, we want you to feel safe, comfortable, and confident throughout your experience with us. To elevate our existing high standards of hygiene and cleanliness, we have developed the Selkirk Tangiers Pure Clean program.

- All guests will be required to complete a pre-trip questionnaire 24 hours prior to participation as well as daily health evaluations in accordance with requirements set out by our provincial health authority throughout their stay.
- All guests will be required to complete an orientation upon arrival familiarizing themselves with cleanliness procedures and protocols to be followed throughout their stay.
- All guests will be designated a "cohort" of up to 5 people, including their guide. Guests will remain with their cohort while skiing and dining throughout their package.
- STHS will provide you with two COVID-19 masks. One mask is intended for you to wear at all times within the common area of the Hillcrest Hotel, including the STHS retail area. The second mask, a "Filtered Neck Tube" (with 99.85% PFE) to be worn while in the STHS shuttle van, in the helicopter or when you cannot maintain the 2-meter distance.
- For updates on STHS & Hillcrest Hotel COVID-19 protocols, please refer to our website.

Safety Rules

- Always listen to the guide's instructions. Don't hesitate to ask for clarification if you are uncertain.
- We are in a remote mountain environment look out for one another and work as a team.
- When skiing or boarding, choose your own fresh line, but always add your tracks to the left or right of the guide's track (guide will specify these instructions before each run). Always be aware of where you are in relation to your guide's track.
- Give a minimum 10-turns head start to the skiers or snowboarders ahead of you.
- NEVER SKI OR BOARD BELOW YOUR GUIDE.
- Always ski or board with a partner, your mutual safety depends on it. This is especially important in the forest, where snow immersion in tree wells can be a serious hazard.
- Do not use pole straps around your wrists/hands poles can get snagged within the trees, potentially injuring your arms or shoulders, and can act as anchors if you are caught in an avalanche.
- If you get lost from the rest of the group **REMAIN WHERE YOU ARE**, we will find you. If you keep moving the situation may become worse. In this scenario, if you have a radio please use it to try and get in touch with your guide to let them know where you are.
- **No music devices** will be permitted as they interfere with vital communications with your group and guide (*see Electronics Policy, pg.7*)
- Cell Phones must be on airplane mode (see Electronics Policy, pg.7)
- No drugs or alcohol consumption during your heli day strictly enforced. Breaking this rule will result in an early end to your heli day as you will be flown home. Please also try to limit consumption the evening before!

Ski Courtesy

- Ski or board into re-grouping areas slowly and under control.
- Take turns going right behind your guide, in the middle of the group, and at the back.
- Always ski & board in control. Most accidents are caused by collisions with other riders or by hitting natural hazards.
- Help other group members if they have fallen and lost skis or equipment.
- When flat areas are encountered, snowboarders have more success traveling near the back of the group where they can ride in tracks made by those in front.
- If a snowboarder is stuck in a flatter section, skiers please lend a pole or assist with a push or helping hand.

Other

- No items can be left in the helicopter between runs, so always ski or board with whatever you bring.
- After your package is complete, please return your transceiver to the STHS retail shop. Leave rental skis or snowboards in the rack outside where a staff member will pick them up.

PLEASE NOTE: STHS reserves the right to remove any guest from their group if the above guidelines are not being complied with!

Electronics Policy



Electronic devices, metallic objects, as well as wireless signals have been found to adversely affect avalanche transceiver performance in both transmit and receive modes. The following is a list of devices which are **PROHIBITED** while skiing with Selkirk Tangiers:

Electronics

- Audio listening devices such as ear buds or built-in helmet speakers attached to any portable listening device.
- Electronic devices with **wireless** capability e.g. GoPro Hero3+ and Smith IO Recon Goggles **with** wireless remote control. *Note: goggles and cameras can be used but remote controls for these devices are not permitted in the skiing environment
- Heart rate monitors.
- Wrist watches with GPS capability and/or Bluetooth capability.
- Any **chest-mounted** electronic device e.g. chest-mounted GoPro.
- Any aerial electronic devices e.g. drone cameras

Clothing

- Clothing with large magnetic buttons and/or large metallic belt buckles and adornments near the chest/waist.
- Electrically heated gloves.
- Any electrically heated clothing systems.

The following is a list of devices that **may** be taken into the heli skiing environment provided that the device(s) can be guaranteed to remain at least **20cm/8 inches** apart from the Barryvox transceiver at all times:

- Cellular/mobile telephones* (see note below)
- Portable radios such as the ones issued by Selkirk Tangiers.
- Personal still picture and motion picture cameras.
- Any metal object including foil wrappers on candy bars and cigarette packages.

In the event of an **avalanche** or lost skier search the following actions must be taken by all persons involved directly in the search:

- <u>Switch off all</u> electronic equipment including cameras and cellular telephones.
- Ensure that all metal objects including electronics and cellular telephones remain at least **50cm/20** inches from the searching Barryvox transceivers.

*A Special Note on Cellular/Mobile Phones

It is important to note that there is no cellular service in our helicopter skiing terrain. Using the phone as a camera is allowed provided the following conditions are met:

- Cell/mobile phones taken into the heli ski environment must be switched to **AIRPLANE MODE** with wifi and blue tooth capability disabled.
- The phone must be kept a minimum 20cm/8 inches away from the Barryvox transceiver at all times.
