1.6.1 If a client cannot travel for their prebooked heliski trip due to travel restrictions related to the COVID-19 pandemic, STHS will provide a full refund for all payments made.

1.6.2 If a client cannot travel for their prebooked heliski trip due to a COVID-19 illness they or a member of their household has, STHS will provide a full refund for all payments made. STHS may ask for a doctor's note outlining the illness in this case.

1.6.3 If canceling for any other reason, the normal cancellation policy outlined in section 1.7 & 1.8 applies.

- 1.7 If cancellation is received by STHS more than ten (10) weeks before trip commencement, the deposit amount for each package being cancelled will be retained by STHS as an administration and cancellation fee.
- 1.8 If cancellation is received by STHS less than ten (10) weeks before trip commencement, the total of all payments for that package will be retained by STHS.
- 1.9 Selkirk Tangiers is not responsible for the clients purchasing of insurance nor for any costs incurred for a cancellation for reasons other than those outlined in sections 1.5, 1.6.1, or 1.6.2.
- 2.0 Pinnacle seats are transferrable but at the discretion and approval of Selkirk Tangiers. Seats must be replaced for the entirety of the package, not on a per day basis.
- 2.1 A reservation will be cancelled immediately if STHS has not received full payment by the due date.
- 2.2 That I will not be permitted to participate in any STHS trip unless a "Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement" is properly signed and witnessed by a qualified STHS staff member.

- 2.8 STHS constructs groups based on client weights outlined on their individual booking form(s). STHS reserves the right to rearrange groups in order to maintain safe group weights as required by Canadian Aviation regulations.
