2021-22 Booking Conditions for Multiday Packages

I hereby apply to book one of the Selkirk Tangiers Helicopter Skiing LLP (also referred to as STHS) trips as specified in the following terms and conditions which I understand and agree to:

- 1.1 That all rates and deposits are in Canadian funds, and that an allowance will be made for exchange if payment is in foreign currency.
- 1.2 That I enclose herewith my initial non-refundable & non-transferable deposit, totaling 15% of the before-tax value for my heli package.
- 1.3 That full payment for all heli package(s) are due and payable to STHS ten (10) weeks prior to the commencement of the package(s) applied for and that full payments are deemed as deposits.
- 1.4 That in cases of cancellation, the cancellation must be received by telephone and confirmed in writing.
- 1.5 If cancellation occurs prior to September 1st, 2021, all payments made towards the heli package are refundable.
- 1.6 If cancellation occurs after September 1st, 2021 the following conditions will apply:

1.6.1 If a client cannot travel for their prebooked heliski trip due to travel restrictions related to the COVID-19 pandemic, STHS will provide a full refund for all payments made.

1.6.2 If a client cannot travel for their prebooked heliski trip due to a COVID-19 illness they or a member of their household has, STHS will provide a full refund for all payments made. STHS may ask for a doctor's note outlining the illness in this case.

1.6.3 If canceling for any other reason, the normal [cancellation policy](#) outlined in section 1.7 & 1.8 applies.

- 1.7 If cancellation is received by STHS more than ten (10) weeks before trip commencement, the deposit amount for each package being cancelled will be retained by STHS as an administration and cancellation fee.
- 1.8 If cancellation is received by STHS less than ten (10) weeks before trip commencement, the total of all payments for that package will be retained by STHS.
- 1.9 Selkirk Tangiers is not responsible for the clients purchasing of insurance nor for any costs incurred for a cancellation for reasons other than those outlined in sections 1.5, 1.6.1, or 1.6.2.
- 2.0 Pinnacle seats are transferrable but at the discretion and approval of Selkirk Tangiers. Seats must be replaced for the entirety of the package, not on a per day basis.
- 2.1 A reservation will be cancelled immediately if STHS has not received full payment by the due date.
- 2.2 That I will not be permitted to participate in any STHS trip unless a "Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement" is properly signed and witnessed by a qualified STHS staff member.
- 2.3 That STHS reserves the right to cancel a package at any time if STHS prescribed safety procedures are not followed including the wearing of approved masks.
- 2.4 That STHS requires all participants to be 15 years of age or older. Participants who are 18 years old or younger must have a parent or guardian to co-sign their waiver as well as ski with them at all times. See 'STHS Minor Policy' for details.
- 2.5 It is understood and agreed that it is my responsibility to arrive at the required time and location to commence any trip. It is also my responsibility to ensure proper entry through Canadian Customs and Immigration if entering from outside Canada.
- 2.6 STHS reserves the right to cancel any heli package at any time. Full refunds will be given in this case.
- 2.7 STHS constructs groups based on guest abilities outlined on this form. If abilities are not homogenous, to the point where it adversely affects the heli program, STHS reserves the right to move guests into other groups that they may fit better with. STHS also reserves the right to not fly a client for their full package if they aren't fit or able to fulfill the minimum fitness and ability level required for that package. No refund to client or agent will be offered in this case.
- 2.8 STHS constructs groups based on client weights outlined on their individual booking form(s). STHS reserves the right to rearrange groups in order to maintain safe group weights as required by Canadian Aviation regulations.
- 2.9 All medical evacuation costs will be the responsibility of the client.

Transceivers Use of an STHS issued Barryvox transceiver is mandatory while skiing with us and it is your responsibility to safeguard and return it to us at the conclusion of your stay. Should the transceiver not be returned, a charge of \$550 + tax will be added to your final bill.

Special Note to Group Organizers The group organizer is responsible to ensure that all guests receive the STHS literature and are fully aware of the policies in it. The group organizer is also responsible for making sure payment deadlines are met. Full group weights are required before STHS confirms any full group booking. If weights do not comply with the maximum we are able to fly safely with, we will not be able to complete the booking as requested and will need to discuss alternatives.
