IKON PASS ACTIVATION/FIRST USAGE

Ikon Pass is sent by post to customers in the USA and Canada. If a customer resides in any other country, they will collect their Ikon Pass in the first Ikon Pass destination they visit. They only need to present their Ikon Pass confirmation number/Itinerary ID at Guests Services in the resort.

Exceptions:

If I am an **Ikon Pass** holder outside of North America, how do I **get** my **pass**?

Once you have purchased your Ikon Pass and received your confirmation by email, your Ikon Pass account is automatically in the system. For access to Chamonix Mont-Blanc Valley, Zermatt, Dolomiti Superski, Kitzbühel, Niseko United, Thredbo, Mt Buller, Coronet Peak, The Remarkables, Mt Hutt, and Valle Nevado, present your ID at a ticket window for a day ticket. You may also visit a North American destination (with the exception of Cypress and RED Mountain) to have your pass printed.
